LWDA Terms & Conditions in relation to the AUCTION

1. A maximum of 35 dogs will be accepted for auction. The Lucindale Working Dog Auction Committee reserve the right to limit numbers if maximum numbers are surpassed. All dogs/pups must be able to demonstrate working ability.
2. The Lucindale Working Dog Auction Committee reserve the right to allocate the catalogue/demonstration order.
3. **Reserve prices on dogs must be submitted with entry form.** Reserves may be changed at the approval of the LWDA Committee up until 14 days before the Auction date.
4. Vendors are requested to register at the LWDA Office by 8:00am on Auction Day.
5. Normal auction terms and conditions apply. The auction will be conducted by representatives of Elders who have been appointed by the Lucindale Working Dog Auction Committee.
6. Settlement will be within **14 working days** of Auction.
7. Dogs passed in at the Auction will be held by the Committee for 60 minutes at conclusion of the entire auction to allow negotiation between Agents and the Under Bidders. The reserve price will be the minimum at which that dog can be sold for on the day.
8. The Lucindale Working Dog Auction Committee or its representative will adjudicate on any disputes.
9. A pre-auction catalogue will be available on Lucindale Working Dog Auction Facebook page and the www.lwdauction.com website.
10. Those who purchase a dog onsite or via AuctionsPlus are required to arrange transport of their dog to them. It is not the responsibility of the LWDA committee to arrange the transport to purchasers.

11. Each entry form must be accompanied with entry fees at \$100 per dog by EFT. Commission of 7.5% of the sale price will be charged by Elders. If you wish to enter more than one dog, you need to complete separate entry forms for each dog.
12. All dogs entered must come with an Australasian Animal Registry transfer of ownership form completed.
13. If you do not have an ABN you are required to fill out a Hobby Declaration Form.
14. Legislation requires all dogs to be Microchipped.
15. Vendors must supply either a DACO or Breeder Source Number.
16. Vendors must not advertise including social media marketing/posts until they have been advised of a successful entry. This will not occur until AFTER the closing date.

LWDA Terms & Conditions in relation to the VENDOR

17. A maximum of 3 dogs per Vendor will be accepted.
18. You will be notified by the committee if your dog is accepted into the auction by the end of August.
19. Vendors must demonstrate their dog in the order allocated. If not prepared, they forfeit their right to demonstrate.
20. Vendors should contact the Lucindale Working Dog Auction Committee as soon as possible if their dog is injured and no longer available for the auction. This may allow them to substitute another dog, subject to approval of the Committee. Dogs cannot be withdrawn from the auction after the 1st of September without a veterinary certificate, entry fee will be refunded on sighting of the veterinary certificate.
21. The vendor agrees to their contact number being printed in the catalogue and displayed online for the purpose of potential buyers to contact them. Vendors are held responsible to proofread their information supplied for the catalogues.
22. Vendors of sold dogs are required to remain onsite to discuss with purchaser the dog's abilities and commands.
23. AuctionsPlus will be on-site, live streaming during the auction. If your dog is sold to an online bidder, the Lucindale Working Dog Auction Committee members will speak to you about the purchaser. The purchaser is to arrange delivery of the dog.

LWDA Terms & Conditions in relation to the DOGS/PUPS

24. Pups are deemed as aged 5 to 9 months of age at the Auction date.
25. All dogs/pups must be able to demonstrate working ability and be tethered. If your pup is not comfortable being tethered, please ensure you supply a suitable cage/crate.
26. The Lucindale Working Dog Auction Committee reserve the right to ballot out dogs to achieve the desired mix and number of dogs but will consult with the vendors involved and refund fees if dogs are omitted. **The Committee's decision is final.**
27. Bitches on heat are not permitted in the Dog Housing area and must stay in the Vendor's vehicle. They will be demonstrated last and auctioned last.
28. Dogs must be in good health. Treated for worms and external parasites prior to auction with a current vaccination certificate. Vendors will need to present this with the Entry Form. **NO CERTIFICATE, NO SALE.** This will be returned to vendor after the auction if the dog does not sell.
29. Vendors who suspect their dog may be aggressive towards stock, other dogs or humans must state this in the catalogue. **This dog must always be muzzled whilst on the grounds.**
30. Dogs being demonstrated must not be allowed to work in a fashion which may lead to stock being mistreated or injured. The vendor may be asked to use a muzzle. The demonstration can be stopped immediately at the discretion of the committee.
31. Collars are to be sold with the dog. You will require your own lead which can be collected after auction.
32. Dogs are NOT to be traded prior to auction. No dog other than those to be auctioned may be demonstrated.
33. The responsibility of the well-being, control and restraint of dogs and their actions rests solely with the owner.
34. Dogs for auction must have no known health issues. The Lucindale Working Dog Auction Committee has the right to request a veterinary inspection of any dog prior to the Auction.
35. The morning of the auction all dogs will be required to be inspected by the Vet onsite to confirm they are microchipped with numbers matching the entry form and are fit and healthy to be demonstrated at the auction.
